- Use Permits for Public Spaces Design Processes by Irena Lazic, Nick Rogers & Walter Gonzalez (30 Mins)
  - O Zoning study used to explore adding a use permit option for the county board to consider case by case modifications of Arlington zoning laws for public spaces to enable more flexibility for amenities and avoid environmentally sensitive areas, while also avoiding adding additional parking. Three studies, including 2-3 public engagements, to be completed by 2024. Proposed amendment allows for modifications for maximum height standards for athletic field lighting and athletic court lighting by the county board through the use permit approval at schools in publicly owned parks and open spaces so long as the lighting was an existing improvement as of the effective date of the zoning ordinance.
- Athletic Field Use Presentation by John Sharkey
  - Yorktown senior project "Senior Experience". Observed 50 hours of 10 fields at 5 parks.
     Fields used in other ways besides athletic field use. Rules regularly ignored especially for dog use.
- APS/DPR MOA updates by Jennifer Fioretti & Greg Anselene
  - Memorandum of Agreements with three high schools being updated. Purpose is to have a written formal understanding of what is expected of each party as it relates to amenities, operations, cost sharing and field scheduling. Cost sharing now closer to 50/50 split. Dear Mr. Dorsey,

In October, the Sports Commission received a presentation from County staff on Use Permits for Public Spaces Design Process. We are sending this letter to show the Commission's support for this proposal.

The proposed changes would provide the County Board with the authority to approve increased height, reduced setbacks, and reduced parking amounts on a case-by-case basis using use permits. The Commission believes this is a strong and needed first step in updating zoning policies that affect public spaces.

The Commission believes that these changes will have several direct benefits:

- Higher Athletic and Sports Field Features: The ability to construct taller athletic and sports field features will allow for more innovative and functional designs that can better cater to the diverse sporting needs of our residents. This will undoubtedly contribute to a more vibrant and active community, and ideally will enable Arlington County to maximize its limited space.
- 2. **Improved Lighting:** Allowing for higher light poles will improve the quality of lighting on existing fields while minimizing the impact on the community. While not part of this study, these changes could ease the process for adding lights to other fields in the future.
- 3. Allowances for domes: Increasing the height limit could allow for domes on existing features. This is another positive zoning change that could provide year-round accessibility to sports facilities and further enhance the usability of our existing infrastructure. The County's positive experience with the Gunston multi-sport indoor facility is proof that domes work.
- 4. **Enhanced Accessibility:** We also look forward to measures that will enhance accessibility to sports facilities, making them more inclusive and user-friendly for individuals of all ages and abilities.

We believe that these zoning changes will benefit our residents but also will reinforce Arlington County's reputation as a community that values and promotes an active and healthy lifestyle.
