

Challenges

Flag Football Tournament Teams are Less Equaitable and Less Accessible There is no current Travel Flag League in our area Elite players may have no Travel Flag experience, but are on Travel teams in other sports Some of these teams form hold tryouts outside of DPR season and play in DPR League NFL FLAG Regional & National Tournaments occur during & after DPR Rec Season ALL DPR Flag Registrants are eligible to participate in NFL FLAG sanctioned tournaments

CONSEQUENCES



PARTICIPATION DECREASE

- Some team refuse to play "tournament teams" in an effort to force those teams out
- Alienating those elite players risks losing those teams
- Could deter future participation



LACK OF PARITY

- Not enough "tournament teams" to form their own division
- Quality teams request to play down creating unfair conditions for beginner teams
- "Tournament teams" won 7 out of the 7 divisions they played in 2021



GROWING TREND

- "Tournament teams" promise of travel after the league makes them more desirable to join
- Model is spreading to boys divisions
- Some teams are creating younger feeder teams
- Arlington representation in tournaments on the rise

Dear Mr. Schwartz,

The Sports Commission is seeking your assistance to resolve the delays in the hiring process which is significantly impacting Arlington's gymnastics program.

Over the years, with the strong support of Arlington County, the Arlington Gymnastics Program grew to a size of over 2200 participants who fully utilize the first-rate Barcroft Park and Sports and Fitness Community Center. At its height, and before the impact of the pandemic, there were nearly 100 coaches and staff to support the program and all its robust activities. Now, there are only 50 (15 permanent employees; 35 temporary), but the number of participants, or demand, has not changed.

From our perspective, the hiring prioritization identified in the enclosed letter to you from the parents – who represent over 200 athletes on gymnastics teams and over 2000 participants in gymnastics programs who compete to be on the County teams – is within our reach to solve: there are applicants applying for open positions, and the program has a great need. The act of hiring will make hiring easier over time if there is a concern of a lack of staff to do the hiring.

In summary, the Commission is asking for your assistance to look into this matter. We appreciate your attention here, and we look forward to hearing from you.

The Sports Commission has reviewed the Field Fund Working Group Final Report, dated July 8, 2021, and we support the Report's findings. We urge the adoption of the updates to the Field Fund that are spelled out in the report.

The Field Fund started in FY11 as part of Arlington's cost recovery model. The fees set at that time have not changed since then. After some initial discomfort with the imposition of the new fees, sports groups have complied with the new requirement and become supportive of the field fund.

Field users have already seen benefits from field fund uses. By FY19 over \$450k in fees had been collected. About \$252k had been spent on diamond field improvements, and \$1.1m is to be used for the Thomas Jefferson MS Upper Field turf conversion that is in process currently.

As the field fund has been in place now for 10 years, it is an appropriate time to review the program. A Field Fund Working Group was created to explore adjusting the fees assessed, based in part on a review of other local jurisdictions' practices. The FFWG also reviewed how those funds are allocated in the different jurisdictions. The resulting report released last Summer offers five suggestions for the fees that feed the field fund:

- A modest increase to field user fees
- The adoption of a sliding scale that charges a slightly higher fee to players aged 9 and above based on field use
- The creation of a Travel Player fee
- To ease the impact of the new Travel Player fee, the group proposed that travel players who play in recreational and travel programs would be exempt from paying the recreational fee for that season
- Increasing the Adult Team Fee from \$100 to \$200

Additionally, it is recommended that the funds be used to cover the annual cost of two (2) additional maintenance staff, for an estimated cost of about \$150,000 per year. The FFWG then proposed that the remaining approximately \$300,000 would accumulate toward large capital investments in one fund (vs. the two separate funds, Diamond Field and Rectangular Field, that

exist now).

The Sports Commission supports the recommendations from the FFWG's Report, namely the five fee adjustments and the use of the fees to support both a unified field fund and provisioning for additional maintenance staff. The increased funding and staffing will work in concert to support the increasing levels of field use that we are experiencing in Arlington, helping to keep our fields in quality condition.
