

## **GENERAL NOTES**

#### SCOPE OF WORK

THIS PROJECT CONSISTS OF THE REMOVAL OF AN EXISTING STEEL EXTERIOR STAIRWAY AND LANDING; REMOVAL OF AN EXISTING UPPER FLOOR LEVEL EXTERIOR DOOR; CONSTRUCTION OF A NEW EXTERIOR WALL CLOSURE OF THE EXTERIOR WALL OPENING RESULTING FROM THE EXTERIOR DOOR REMOVAL; ASSOCIATED INTERIOR FINISH WORK AT THE UPPER LEVEL CLASSROOM; AND INSTALLATION OF A NEW GUARDRAIL AT THE EXISTING LOWER LANDING WHERE THE EXISTING EXTERIOR STAIRWAY SPRINGS FROM.

#### **DEMOLITION**

ALL MATERIALS WHICH ARE TO REMAIN AND ARE DAMAGED BY DEMOLITION SHALL BE REPLACED WITH MATERIALS TO MATCH EXISTING.

CONTRACTOR SHALL NOTIFY OWNER IMMEDIATELY OF ANY INTENDED STRUCTURAL LOAD-BEARING DEMOLITION (OWNER ANTICIPATES NONE).

CONTRACTOR SHALL ERECT A DUST PARTITION IN THE UPPER LEVEL CLASSROOM TO AVOID CONTAMINATION OF ADJACENT INTERIOR SPACES.

CONTRACTOR SHALL ERECT TEMPORARY BARRIER TO SECURE UPPER FLOOR LEVEL EXTERIOR DOOR BETWEEN DEMOLITION AND NEW WORK CONSTRUCTION.

#### NEW WORK

CONTRACTOR TO FIELD VERIFY ALL DIMENSIONS AND MEASUREMENTS PRIOR TO STARTING WORK.

DO NOT SCALE DRAWINGS. WRITTEN DIMENSIONS GOVERN. IN CASE OF CONFLICT, CONSULT ARCHITECT.
