Pursuant to Arlington County Code Chapter 13, the possession, carrying or transportation of firearms, ammunition or components or combinations thereof is prohibited, unless otherwise authorized by law. Any person violating County Code Chapter 13 shall be guilty of a Class 1 misdemeanor and may be subject to up to 12 months in jail, a fine of up to \$2,500, or both.

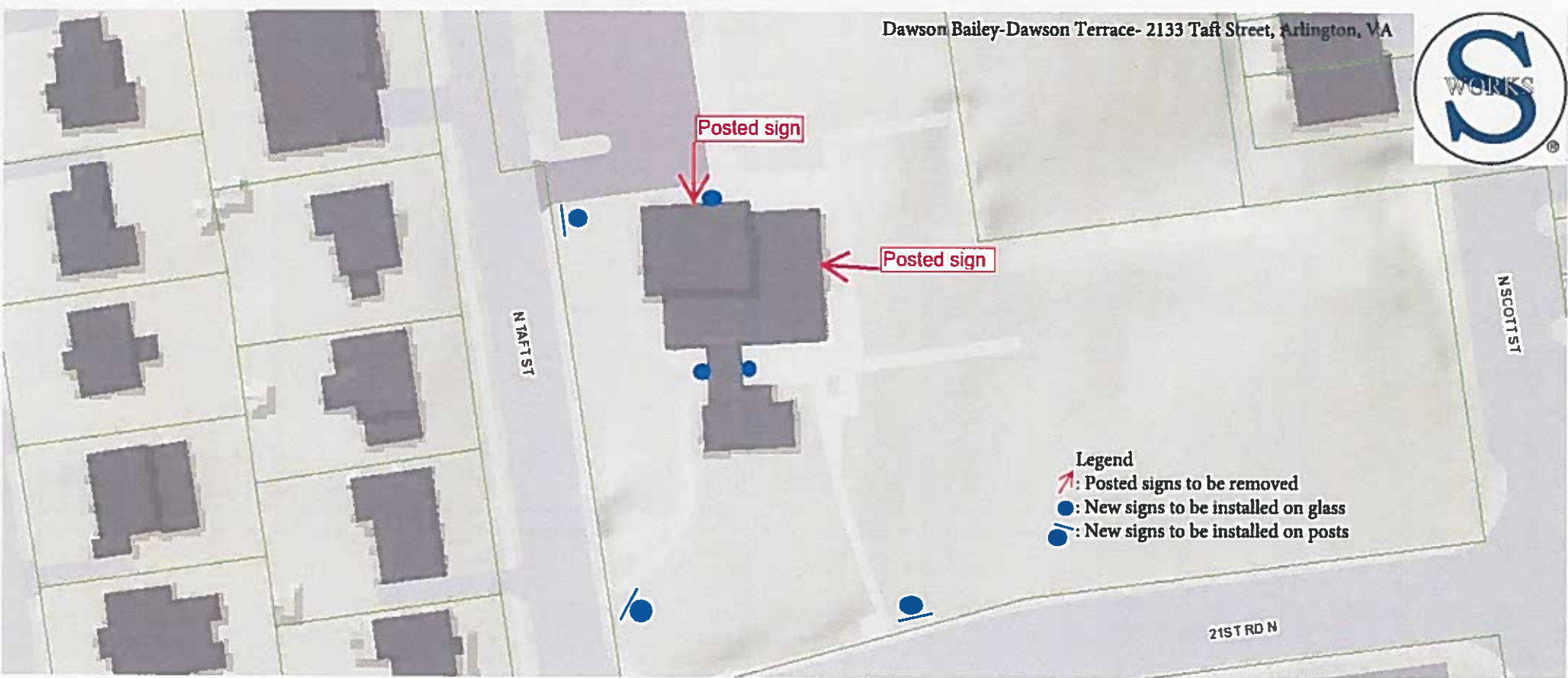

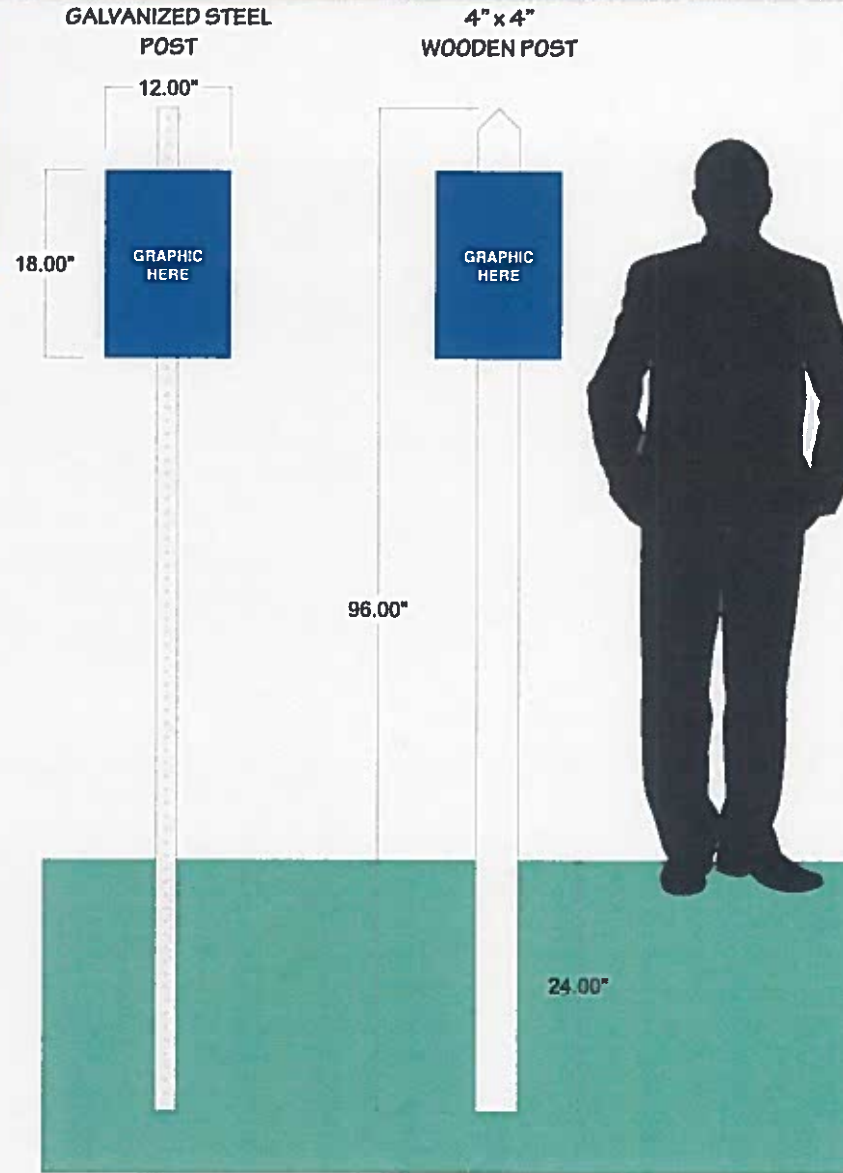
