## MT. SALVATION BAPTIST CEMETERY

THIS CEMETERY HAS BEEN MAINTAINED BY THE MT. SALVATION BAPTIST CHURCH TRUSTEES SINCE 1892. REVEREND CYRUS CARTER CULTIVATED THE CONGREGATION WHICH BEGAN AT THE NEARBY HOME OF ISABELLA WASHINGTON AND MOSES PELHAM, SR. IN 1884, THE TRUSTEES ACQUIRED THIS SITE FOR \$80. THE CEMETERY CONTAINS AT LEAST 89 KNOWN BURIALS FROM 1916 TO 1974, ALTHOUGH THERE LIKELY ARE EARLIER BURIALS.

THIS IS THE FINAL RESTING PLACE OF MANY COMMUNITY LEADERS. MEMBERS OF THIS CHURCH PROVIDED STABILITY AND SOCIAL SUPPORT THROUGHOUT SEGREGATION AND SERVED AS ONE OF THE PILLARS OF ARLINGTON'S BLACK COMMUNITY. THE CEMETERY BECAME AN ARLINGTON HISTORIC DISTRICT IN 2021.
