Meeting location: Virtual through MS Teams

- 1. Kathy Reeder, Chair, welcomed the Committee to the meeting
- 2. Roll Call: Neighborhood Reports
  - a. Gretchen Carter (Alcova Heights) A thank you to Tim and Naudy for coming out to look at a possible new sidewalk project
  - b. Lauren Bailey (Arlington Ridge) Are the draft letters still needed, as the deadline has passed, just waiting on president signature. Kathy indicated they are still needed, and include the amount of money in the letter, as well
  - c. Kathy Reeder (Glencarlyn) The 4<sup>th</sup> St S project is moving along nicely. The neighborhood will be planning a celebration block party; will be inviting staff.
- 3. Introduction of new NC Representatives: Don Bennett (Barcroft); Eric Malpeli (Old Dominion); and Carter Echols (Arlington View)
