

- Research, feasibility, preliminary concept designs for ~10 top ranked locations
- Staff advise on projects for NCSC vote to proceed
- February 27, 2023 NCSC • meeting

- Public engagement • planning & execution
- Review feedback, and • incorporate any revisions
- Complete "Concept • Plan" and cost estimate
- May-June 2023



- Location: 14<sup>th</sup> Street North from North Ohio Street to North McKinley Road in Highland Park Overlee Knolls
- **Scope:** Install continuous sidewalk on the north side of the street, ADA curb ramps, high visibility marked crossings, and working within existing constraints
- Public Engagement: project webpage, online feedback form, fliers, virtual NCS capital projects open house, meeting on site, shared on DES communication channels
- **Points:** 48 points 4<sup>th</sup> on list
- Cost Estimate: approx. \$587,000









# 8<sup>th</sup> Road South

- Location: 8<sup>th</sup> Road South between South Dinwiddie Street and South Greenbrier Street in Arlington Mill
- **Scope:** Install new curb extensions and, accessible curb ramps, marked crossings, and improved signage
- **Public Engagement:** project webpage, online feedback form, fliers, virtual NCS capital projects open house, shared on DES communication channels
- **Rank:** 46 points tied for 6<sup>th</sup> on list
- Cost Estimate: approx. \$478,000




## **S Irving Street Corridor**

 3 Separate segments originally nominated:

• Segment A: 2<sup>nd</sup> St S to 6<sup>th</sup> St S – School Slow Zone & NCS capital project candidate • Segment B: 6<sup>th</sup> St S to 7<sup>th</sup> St S – funded NCS capital project construction ~2024 Segment C: 7<sup>th</sup> St S to 9<sup>th</sup> St S – segment for future improvements (WSS has performed concrete shaving)



- Location: South Irving Street from 2<sup>nd</sup> Street South to 6<sup>th</sup> Street South in Arlington Heights
- **Scope:** Replace Carlyle lights located in 4' sidewalk with new Carlyles located in curb extensions, accessible curb ramps
- Public Engagement: project webpage with two options, online feedback form, fliers, virtual NCS capital projects open house, AHCA meeting, block meeting, shared on DES communication channels
- Rank: 51 points 2<sup>nd</sup> on list
- Cost Estimate: approx. \$522,000










Sidewalk on the east side obstructed by utility poles




Net change to on-street parking: -6 Two lighting options presented at engagement - Carlyle lights preferred and included in proposed design
