

## Background

- 3108 Columbia Pike was acquired by the County in March 2022
- Interim Use: Serve as APS overflow parking during Career Center redevelopment
- Future Use: Potential site for the relocated Columbia Pike Library and County Board priorities such as affordable housing; community engagement process for the long-term vision to be determined

- 63 parking spaces


 Expand parking lot from 63 spaces to 92 spaces



# Proposed GLUP Amendment, Rezoning and Use Permit

As part of the redevelopment process, several planning actions are required:

- 1) A <u>General Land Use Plan (GLUP)</u> amendment to the Public Facility Map and Table to identify this site for a proposed *publicly-owned parking lot* as a feature shown in the County's Comprehensive Plan.
- 2) <u>Rezoning</u> from R-5 (One-Family and Restricted Two-Family Dwelling District) and C-2 (Service Commercial-Community Business District) to S-3A (Special District) shown at right
- 3) A <u>Use Permit</u> to allow for APS Career Center staff and contractors to use the property as overflow parking.
