### **CIP Process**

- Winter/Spring the County Manager gathers input from his leadership team, County staff, the County Board and the Arlington community. This input help frame and develop the Manager's Proposed CIP, which he will present to the Board.

- June and July the County Board holds work sessions to learn more about the specifics of the CIP proposals. The Board also holds a public hearing and receives community feedback as it considers the Manager's CIP proposal.
- July, following extensive review and consideration, the County Board adopts the final CIP.



### Transit CIP Overview

- In FY21, the County adopted a one-year CIP due to the ongoing impacts of the COVID-19 pandemic
  - Transportation CIP was \$155M and included \$38.4M for Transit
- In FY22, the County adopted a 3-year CIP FY22 FY24
  - Transportation CIP was \$568M and included \$321M for the Transit
- In FY23, the County will return to a full 10-year CIP FY23-32 that will be updated biennially
  - Development of the Transit CIP is underway with a projected 10-year forecast of nearly \$450M in projects/programs

- Project Location
  - Ballston-MU Metro Station
- Objective
  - Upgrade and modernize the Ballston-MU Metro Bus Bays & Plaza
- Construction Schedule
  - Started June 2020
  - Completion Summer 2022
- Construction Cost
  - > \$5.5 million













### Ballston-MU Multimodal Construction Phases



- Major Construction Phases
  - > Phase 1: Fairfax Dr substantially complete with bus bays in service
  - Phase 2: N Stuart St bus bays built and planter installation underway; expected completion summer 2022
  - ➤ Phase 3: N Stuart St plaza work to start in spring 2022
  - ➤ Phase 4: Fairfax Dr plaza work underway



### Ballston-MU Metro West Entrance

- Design and construct a second entrance to the Ballston –MU Metro Station at Fairfax Drive and N Vermont Street
- New entrance enhances connectivity within the Ballston area
  - Extends the distance pedestrians can reasonably walk to access the station by nearly one-quarter mile
  - Relieves congested conditions by providing more even distribution along the platform
  - Provides additional egress path for evacuation during an emergency
  - County-led project with coordination with WMATA
  - Proposed FY23-32 CIP Project Budget is \$140M



**Ballston West Entrance Project Location** 




### Ballston-MU Metro West Entrance Funding

- County recently submitted funding applications in the amount of \$84.5M for the Ballston West Entrance project
  - Northern Virginia Transportation Authority (NVTA)
     FY2022-27 Six-Year Program \$80M application
  - Northern Virginia Transportation Commission (NVTC) I-66
     Commuter Choice \$4.5M application
- Public Comment Period Spring 2022
  - Community is encouraged to submit letters of support to both NVTA and NVTC (more details to follow)



### Ballston-MU Metro West Entrance


- County's on-call A&E consultant advancing 35% design of new entrance
- Design must comply with WMATA's current design criteria and standards "Challenging"
  - Number of elevator (2 elevators per change in level)
  - Size of mechanical equipment increased
  - Emergency egress stairs required
  - Approach for opening station vault wall (structural integrity)



Ballston West Metrorail Station (western end of platform where new mezzanine will be located)






Includes stairs and two-street level elevators connecting to a fare payment area, an underground passageway

# East Falls Church Metro Bus Bay Expansion

- County issued task order to STV for design and engineering in October 2021
  - > 30% design underway
  - ➤ 60% design in May 2022
  - ➤ 100% design in August 2022
- Issue Invitation to Bid (ITB) fall 2022
- Anticipate construction contract award end of 2022
- Public outreach includes:
  - Virtual community meeting March 1
  - Station pop-up event station spring 2022
  - WMATA Compact Public Hearing spring/summer 2022
- Coordination with adjacent projects underway





### East Falls Church Metro Bus Bay Expansion


#### 2015 study findings:

- Bus bays are at capacity
- Pedestrian and ADA access improvements are needed
  - Long pedestrian crossing distance (~150') at bus entrance
  - Non-ADA compliant ramps
