
#### Department Overview

- Upgraded 2 GDC, 2 JDR and 4 Circuit Court courtrooms to reliably support remote hearings
- Modified marriage license, probate,
   & notary oath procedures to
   facilitate remote appointments
- Upgraded eFiling system to enable more cases to be initiated electronically
- Increased the volume of eFiling and eRecordings to reduce the processing and storage of paper



#### Department Overview

- Land records division collects local grantor and grantee fees
  - 8% increase from FY19 to FY20
  - 31% increase from FY20 to FY21 projected
- Other fees include:
  - Will and administrative fees
  - Local fines
  - Courthouse maintenance
  - Law library
  - Reproduction fees
  - Concealed handgun permit fees
  - Relatively consistent year over year



## FY 2022 Budget Highlights

- Increased usage of technology in the courthouse is driving need for more support and is reflected with FTE increase
  - Remote hearings
  - Digital evidence including Body Worn Camera footage
- Need a 5th Courtroom Clerk to support court operations when a clerk is absent
  - Sometimes a 5<sup>th</sup> Judge brought in requiring staffing for 5 courtrooms
- Need the Land Records unfunded, temporary position converted to permanent FTE position
  - Land records recordings increasing by over 70%
  - Arlington's leaders have created a place where people want to live and work
  - Historically low interest rates driving an increase in refinancing
  - An increase in land related transactions related to Amazon's presence

# CCT in the COVID-19 Pandemic

- Implemented a teleworking rotation schedule to support the delivery of critical services while minimizing risks of exposure
- Developed new procedures to perform essential services remotely via video versus in-office
- Deployed a call center to enable in-office and teleworking staff to handle the increased call volume
- Deployed Surface devices and Surface
   Hubs to facilitate remote hearings with the
   detention center and other external
   parties



## Focus on Equity

- Coordinated with Arlington Public Schools to have families access deeds electronically to validate residency for school enrollment
- Updated policy to accept electronic notarizations to facilitate document recordation
- Deferred completion dates of community service hours and payments plans
- Waived notary service on petition for fines, costs and restitution
- Created uncontested no-fault divorce packet and fillable PDF forms that allow customers to forego having to hire attorneys for some basic legal situations
- Posted a form on Land Records webpage that allows property owners a mechanism to release particular unconstitutional and discriminatory covenants for a minimal recording fee

- Land records recordings projected to increase over 70% from FY2020
- Civil cases projected to increase 38% from FY2020
- Criminal cases projected to decrease 12% from FY2020
- FTE increase is to support BWC and technology needs throughout all courts
- Staff processing land records recordings and case filings has remained flat

#### Key Budget Considerations

- CCT transactions projected to generate over \$12M County revenue in FY 2021
  - Land records recording and civil case filing growth is expected to continue
  - Current Land Records unfunded, temporary position should be converted to a permanent FTE
- Need a 5th Courtroom Clerk to support court operations
- Increased use of remote hearings and digital evidence is driving need for technology support
