



Reducing Vehicular Impact



County non-public safety sedans electric by end of FY 2023

New electric vehicles (EV) purchased

Projected purchase of EVs in FY 2023



- \$200K to support EV charging infrastructure for County fleet operations
- **\$125k** for public-use EV charging infrastructure
- 21 EV charging stations pending installation
- Addition of a Project Manager to manage EV charging stations & solar panels

Affordable Housing Proposed FY 2023 Budget

Commitment to Affordable Housing

Continued emphasis on housing support, eviction prevention and increasing supply.





Partnership between Community Planning, Housing and Development (CPHD) & **Department of Human Services** (DHS) to secure and place clients into units.

Preserving and Creating Long-term Affordable Housing

County's main financing program. Affordable **Housing Investment** Fund (AHIF), helps to create and preserve affordable housing units for 60 years or more.

Assists residents earning 30-60% Area **Median Income (AMI)**

\$16.9M

Proposed budget maintains prior year's funding level for AHIF.

Growing Demand for Direct Housing Assistance

Permanent Supportive Housing

for residents with low-incomes, disabilities and housing insecurities



- Addition of \$588K for total of \$3.6M to increase projected households served from 263 to 289.
- Increases average monthly grant from \$1,030 to \$1,066.
- Year-to-year, 96% of residents retain housing, contributing to decline in homelessness.
- Growing demand with 50 people on waitlist.

Housing Grants

- **\$2.3M** in one-time funds for an overall budget of \$14.3M.
- Provides rental subsidy to households with very low-incomes approximately 90% of households served have incomes less than 30% AMI.
- Housing Grant Study underway to review program and provide recommendations to meet changing community needs. Findings coming Fall 2022.



Eviction Prevention

FY 2023 \$1.4M

• **\$1.4M** in one-time funding (ARPA) in FY 2023 to meet increase in requests for assistance since start of the COVID-19 pandemic.

Federal Housing Choice Vouchers

- **\$23M** in federal funding for housing choice vouchers, an 8.3% increase
- In addition to working with developers to identify more units. DHS works with landlords to create flexibility in leasing requirements to remove barriers for individuals to find places to live.

Increasing Access for Residents to Jobs

• \$297K added in FY 2023 for DHS Workforce Innovations & Opportunities Act (WIOA)

 Approx. 150-200 clients with employment barriers will be served



Equitable Access to COVID-19 Care

Since 2020, DHS led all aspects of COVID-19 efforts, including exposures, infections, vaccinations

Expanding Mental Health Services

Crisis Intervention Center (CIC) at DHS Sequoia, a vision for 24x7 facility to provide alternate care for individuals experiencing mental health crises

• Will function as drop-off site for individuals in police custody experiencing behavioral health

(19 total staff) to provide around the clock crisis stabilization

Community Regional Mobile Crisis Response



Grant increase (\$4M total) to expand program to include adults

Marcus Alert

- Partnership between DHS and public safety to address behavioral health 9-1-1 calls
- \$111K ARPA-funded 1.0 FTE to ensure compliance with Marcus-David Peters Act
- Produce Arlington's Marcus Alert Local Plan and ensure standards and best practices maintained
- Evaluate existing services, collect, and analyze data

Recruitment and Retention



Continued challenges with attracting and retaining talent in Police and Sheriff



What we're doing

- 6.5% merit-based increases for uniformed employees
- Police recruitment funding
- Pay premium increases for Patrol Officer field training, civil disturbance unit and SWAT
- \$1600 gross bonus
- Implementing collective bargaining ordinance
- Reduction of work week for Fire (Kelly Day)
- Expanding Public Safety Wellness Initiative

Racial Equity





- Civilian Oversight Board
- Traffic enforcement & policing
- Mental health & policing
- Increasing engagement opportunities with underrepresented populations
- Applying equity in policies and procedures, recruitment, hiring and promotions
- Strengthening professional development
- Partnership with DHS to address behavioral health 9-1-1 calls as part of Marcus Alert

Expanding Emergency Services



Investment in 9-1-1 remote dispatch technology to improve redundancy

ET3: Emergency Triage, Treatment and Alternate Transport

- Enhances emergency medical service to allow telemedicine, treatment in place or alternate transport
- **Promotes patient equity** with more EMS delivery options
- Patient-driven choice for lower acuity medical conditions
- Potential lower-cost medical care


