## FY 2025 Proposed Capital Budget CIP Work Session

The following information is provided in response to a request made by Ms. Coffey at the work session on 06/11/2024, regarding the following question:

Please provide the list of facilities with current facility condition indexes (FCIs).

Please see the facility list included below with current facility condition indexes (FCI). The indexes shown represent the condition during the last assessment performed in 2020 and encompass all aspects of the facility, including programmatic equipment. The Proposed CIP includes funding in FY 2029 to update the Facility Condition Assessment (FCA) database. We normally update the FCA every five to seven years; given the evolving nature of space usage post-COVID, we delayed the FCA update until 2029 but we are still conducting updated assessments periodically as needed.

The condition index is a score from zero to 1.0 and determined by the inverse cost to replace the systems or infrastructure that have reached the end of their useful life in comparison to the total facility value. A lower score is an indicator that facility investment is needed to maintain a state of good repair.

Because the FCI is based on field inspections and age of the asset, and assumes continued use, it does not account for the natural and appropriate judgments when a facility is likely to be demolished, vacated, or experience a change in use in the near term. The list below attempts to address this with notes for context on many of our lowest ranked facilities.

FCI is not the only indicator when determining facility investment priorities. A low score for a facility does not necessarily increase its priority for individual system investment or total replacement but does influence further review of identified systems. A more detailed breakdown is required when reviewing individual facility scores as a single system (e.g., an aging roof that is at risk of failure) can highly influence the overall score. The score also does not include any reference to specific program use of the facility and the potential for change in use depending on community needs. Facilities with higher scores may not be reflective of Facility Management Bureau's real time observations, such as increased maintenance issues which could impact operating costs and program operations—which could bump a facility higher in priority. Additionally, other factors such as ADA and historic preservation requirements could impact the magnitude and scope of the investment and change its relative priority. Lastly, it is important to note the FCA is a point in time and updated periodically, so it does incorporate updates as facility investments are made.
