RESOLUTION RE-ESTABLISHING THE COMMUNITY CRIMINAL JUSTICE BOARD.

- WHEREAS the Virginia General Assembly adopted legislation entitled the Comprehensive Community Corrections Act for Local-Responsible Offenders (Sections 9.1-173 et seq. of the Code of Virginia) and the Pretrial Services Act (Sections 19.2-152.2 et seq. of the Code of Virginia), both of which are in effect; and
- WHEREAS the Comprehensive Community Corrections Act for Local-Responsible Offenders and the Pretrial Services Act both mandate that any city, county, or combination thereof that is required to file a community-based corrections plan pursuant to Section 53.1-82.1 shall develop, establish, and maintain a local community-based probation services agency and a pretrial services agency; and
- WHEREAS the Arlington Community Corrections Program and the Arlington Pretrial Program have previously served the City of Falls Church and the County of Arlington, and provided the judicial system and its officers with enhanced information, and risk assessments, as well as sentencing alternatives for certain misdemeanants and persons convicted of non-violent felonies; and
- WHEREAS the Arlington Community Corrections Program and the Arlington Pretrial Program will continue to provide the judicial system and its officers with local community-based probation services and pretrial services to these same localities; and
- WHEREAS Sections 9.1-178 and 19.2-152.5 of the Code of Virginia require that each county and city participating in local community-based probation services or pretrial services establish a Community Criminal Justice Board and, in the case of multijurisdictional efforts, that each jurisdiction mutually agree upon the composition of said Board; and that the Board has been established prior to the drafting of this resolution; and
- WHEREAS the continued operation of a multijurisdictional Community Criminal Justice Board will result in a reduction in administrative costs to each locality, improved funding of priorities and available grant dollars, efficiency in offender supervision, increased diversion from incarceration and reduced recidivism, modern correctional services, and a forum through which to address challenges facing the criminal justice system.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF THE COUNTY OF ARLINGTON, VIRGINIA that the City of Falls Church and the County of Arlington will continue to abide by the Comprehensive Community Corrections Act for Local-Responsible Offenders and the Pretrial Services Act, and that the Arlington Community Corrections Program and the Arlington Pretrial Program shall be responsible for said continued operation of local community-based probation services and pretrial services, respectively; and

BE IT FURTHER RESOLVED that the Community Criminal Justice Board ("CCJB or "Board") is hereby re-established; that the membership of the Board, as mutually agreed upon by the City of Falls Church and the County of Arlington, shall be composed of the following seats, and the members shall be appointed by the governing body so indicated; that each appointment shall be reported to the Clerk of the Board of the County of Arlington; and that, unless otherwise indicated herein, no limitations shall be placed on the terms of membership:

BE IT FURTHER RESOLVED that the CCJB shall adopt Bylaws which shall include, but not be limited to, the creation of committees; the election, in odd-numbered years, of a chair and vice chair as the CCJB's Officers; the creation and composition of an Executive Committee; and the frequency with which the CCJB will meet, which shall be at least quarterly. Such bylaws shall be reviewed, at a minimum, every two years; and

BE IT FURTHER RESOLVED that the Clerk of the Board of the County of Arlington, or their designee, shall be the custodian of all records related to the CCJB and shall serve as the primary staff liaison until such other person or entity is designated as such by the CCJB membership through duly approved Bylaws; and

BE IT FINALLY RESOLVED that the CCJB shall publish a Strategic Plan every five years, beginning in 2025, which shall objectively assess the community's needs and resources and ensure the comprehensive evaluation, development, and operation of local pretrial services, local community-based probation services, and other programs that benefit the community.
