The members shall be: one (1) representative from the Police Department, one (1) representative from the towing industry, and one (1) citizen representative. All members serve at the pleasure of the County Board for three (3) year terms. The Chairman shall be elected annually from among the voting members of the Advisory Board by a majority vote and shall rotate annually between a representative of a local law-enforcement agency, a representative of a licensed towing and recovery operator, and one member of the general public.
