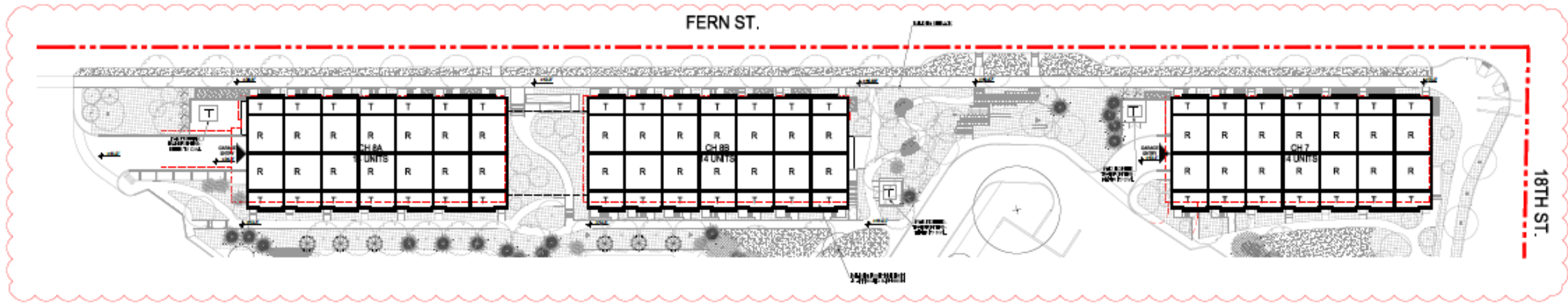

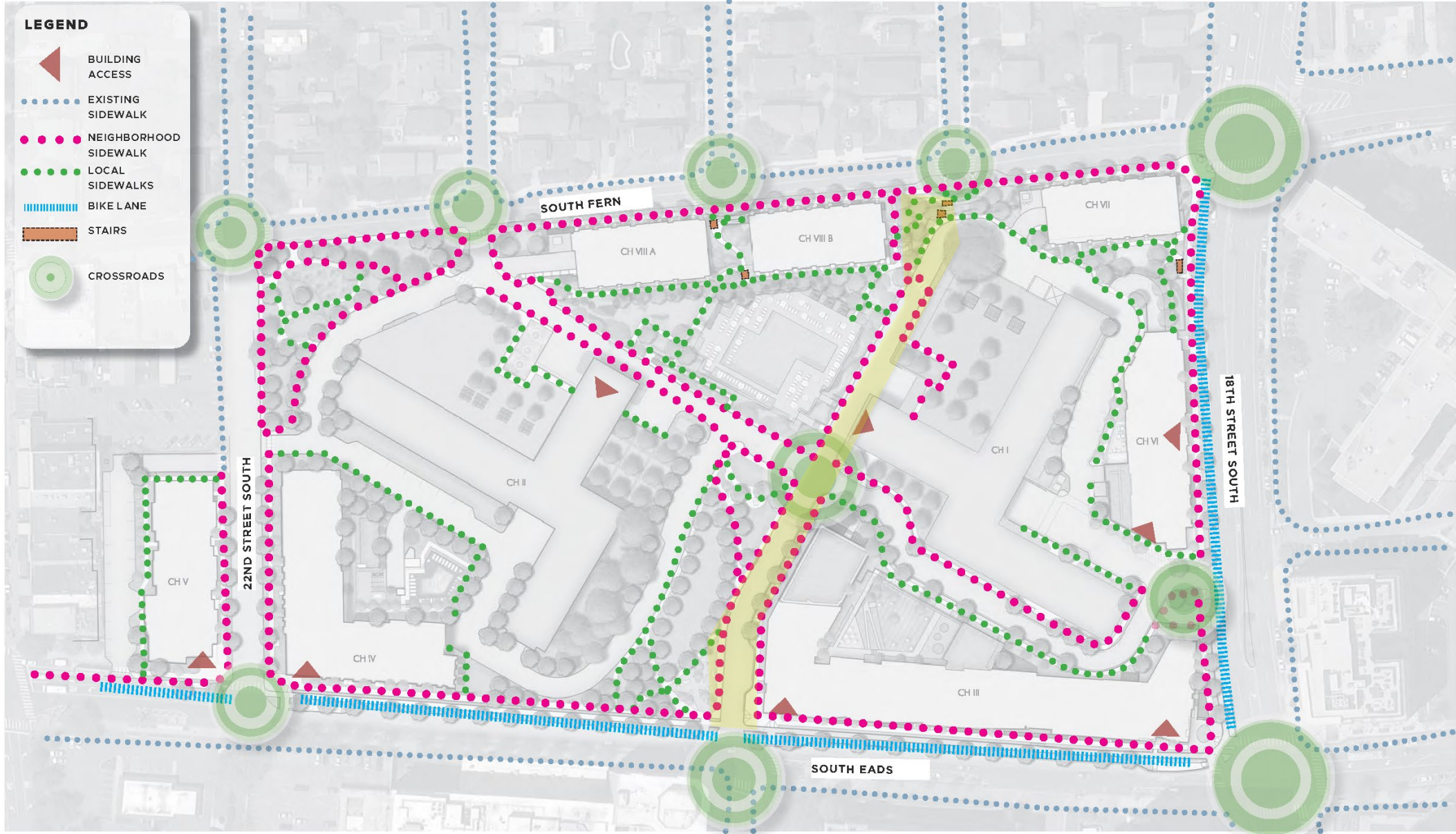

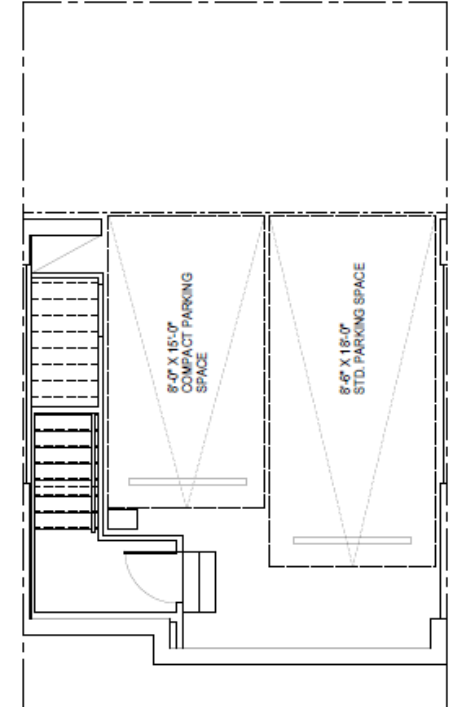

ROOF PLAN

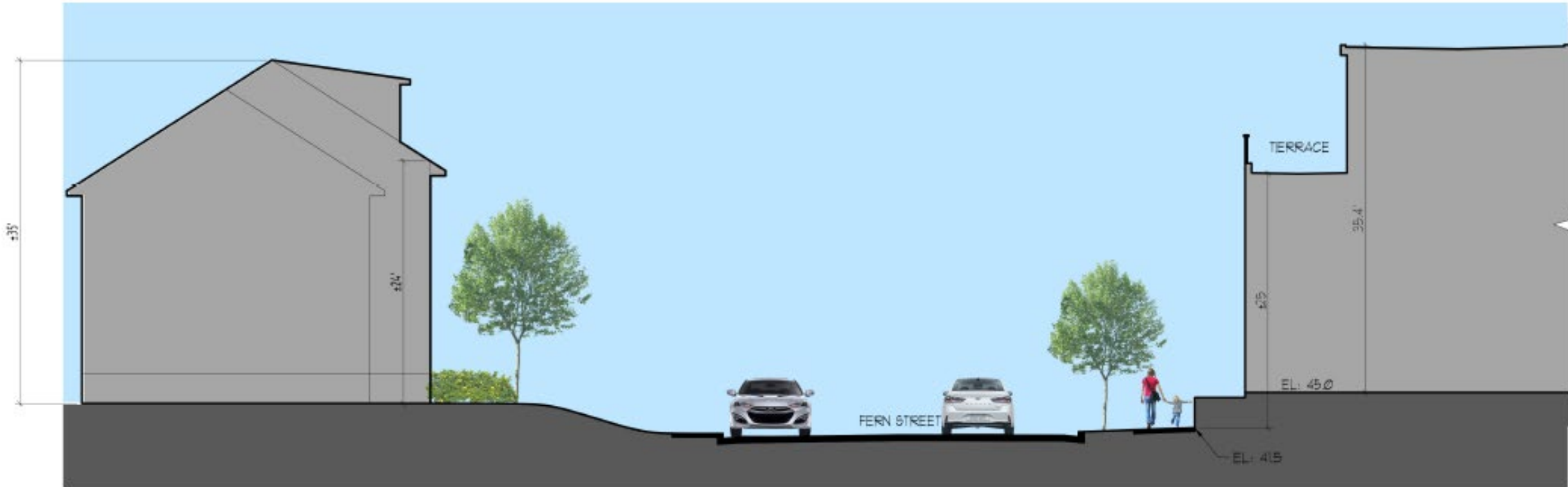
LOFT FLOOR PLAN

SECOND FLOOR PLAN

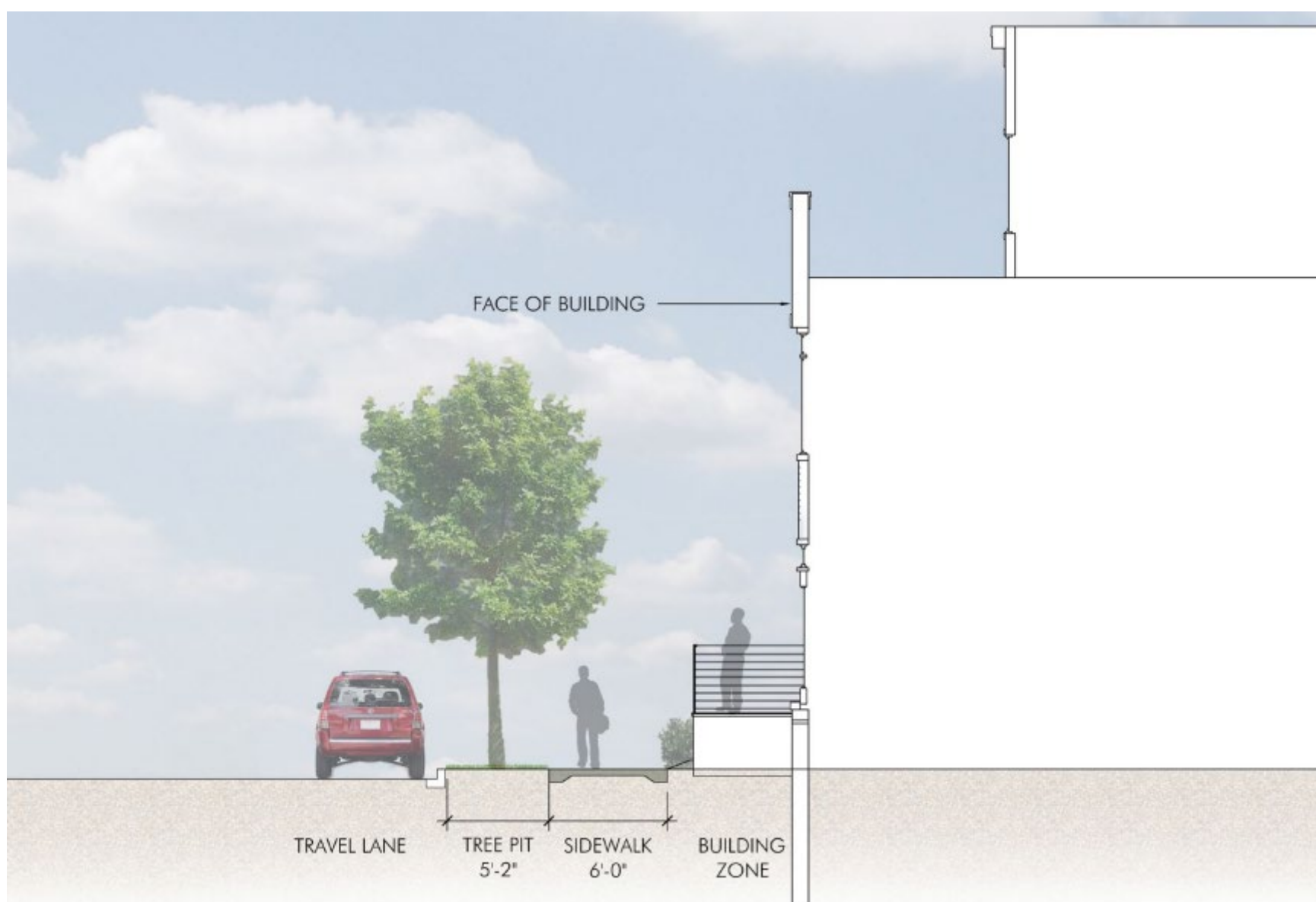
GROUND FLOOR PLAN

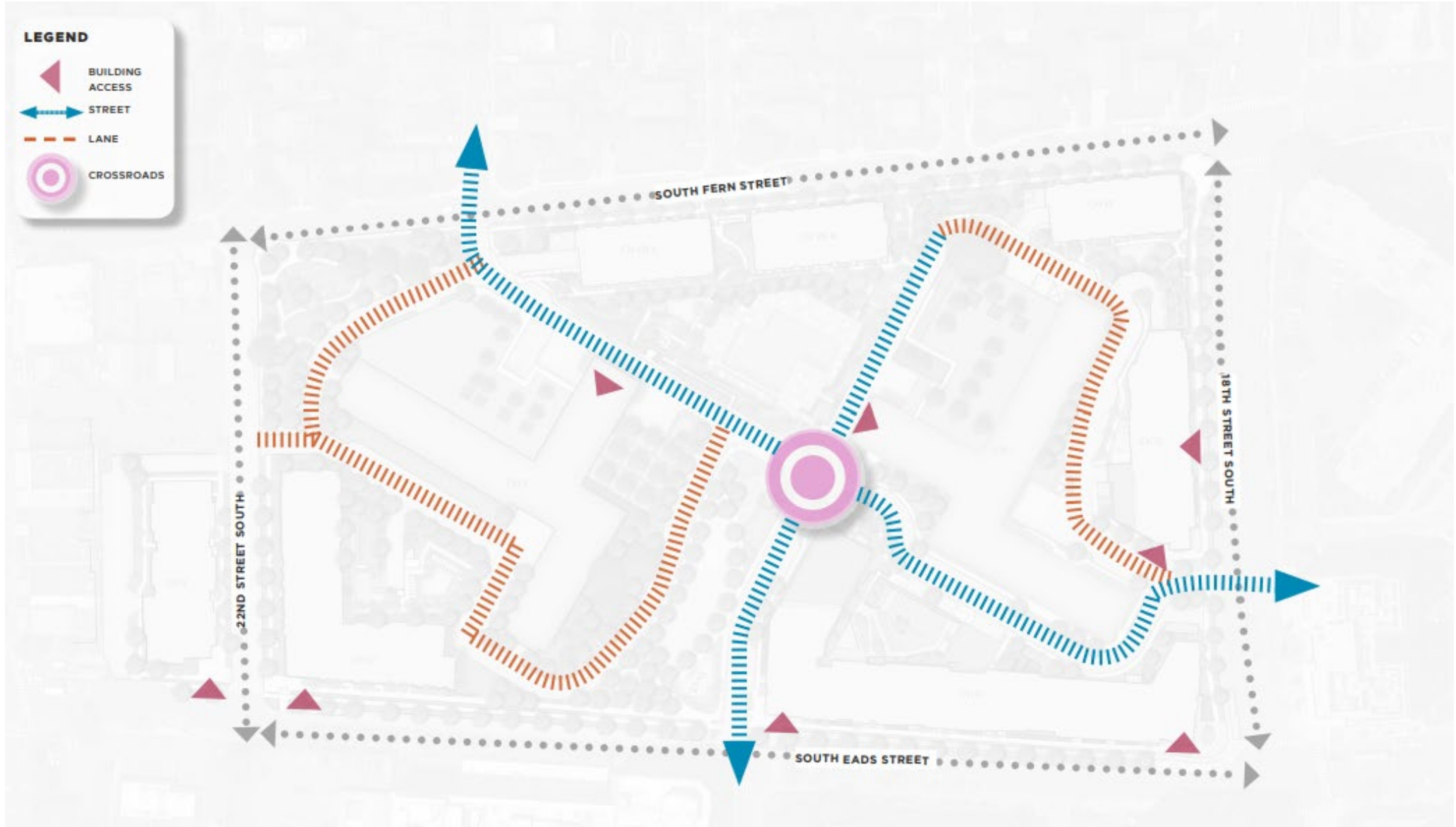

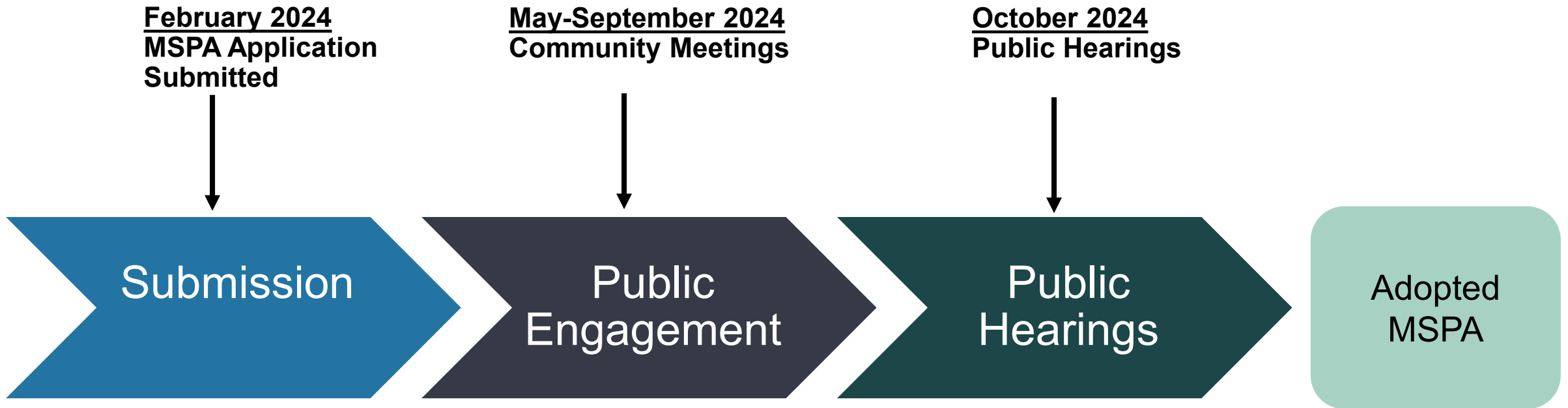




Vehicular Site Circulation
