





Rendering View from Fairfax Drive and Troy Street





Green Building Incentive Program (0.35 FAR)

 - ENERGY STAR appliances and WaterSense fixtures
 - EV charging (4%) and infrastructure (15%)
 - Bird-friendly façade materials (between 8-36 ft)
- ✓ Extra List Options:
 - Envelope commissioning and air leakage test
 - Renewable energy procurement
 - Whole building life cycle impact reduction
