## **Freedom of Information Act Rights**

The Rights of Requesters and the Responsibilities of The Arlington County Sheriff's Office under the Virginia Freedom of Information Act (VFOIA)

The Virginia Freedom of Information Act (FOIA), located § 2.2-3700 et seq. of the Code of Virginia, guarantees citizens of the Commonwealth and representatives of the media access to public records held by public bodies, public officials, and public employees.

A public record is any writing or recording -- regardless of whether it is a paper record, an electronic file, an audio or video recording, or any other format -- that is prepared or owned by, or in the possession of a public body or its officers, employees or agents in the transaction of public business. All public records are presumed to be open, and may only be withheld if a specific, statutory exemption applies.

The policy of FOIA states that the purpose of FOIA is to promote an increased awareness by all persons of governmental activities. In furthering this policy, FOIA requires that the law be interpreted liberally, in favor of access, and that any exemption allowing public records to be withheld must be interpreted narrowly.

### **Your FOIA Rights**

- You have the right to request to inspect or receive copies of public records, or both.
- You have the right to request that any charges for the requested records be estimated in advance.
- If you believe that your FOIA rights have been violated, you may file a petition in district orcircuit court to compel compliance with FOIA. Alternatively, you may contact the FOIA Council for a nonbinding advisory opinion.

## Making a Request for records from Arlington County Sheriff's Office

• You may request records by U.S. Mail, fax, e-mail, in person, or over the phone. FOIA does not require that your request be in writing, nor do you need to specifically state that you are requesting records under FOIA.

- From a practical perspective, it may be helpful to both you and the person receiving your request to put your request in writing. This allows you to create a record of your request. It also gives us a clear statement of what records you are requesting, so that there is no misunderstanding over a verbal request. However, we cannot refuse to respond to your FOIA request if you elect to not put it in writing.
- Your request must identify the records you are seeking with "reasonable specificity." This
  is a common-sense standard. It does not refer to or limit the volume or number of
  recordsthat you are requesting; instead, it requires that you be specific enough so that
  we can identify and locate the records that you are seeking.
- Your request must ask for existing records or documents. FOIA gives you a right to
  inspect or copy records; it does not apply to a situation where you are asking general
  questions about the work of the Arlington County Sheriff's Office. nor does it require the
  Arlington County Sheriff's Office to create a record that does not exist.
- You may choose to receive electronic records in any format used by the Arlington County Sheriff's Office in the regular course of business.
  - For example, if you are requesting records maintained in an Excel database, you
    may elect to receive those records electronically, via e-mail or on a computer
    disk, or to receive a printed copy of those records
- If we have questions about your request, please cooperate with staff's efforts to clarify the type of records that you are seeking, or to attempt to reach a reasonable agreement about a response to a large request. Making a FOIA request is not an adversarial process, but we may need to discuss your request with you to ensure that we understand what recordsyou are seeking.

## The Arlington County Sheriff's Office Responsibilities in Responding to Your Request

- The Arlington County Sheriff's Office must respond to your request within five working days of receiving it. "Day One" is considered the day after your request is received. The five-day period does not include weekends or holidays.
- The reason behind your request for public records from the Arlington County Sheriff's
  Office is irrelevant, and you do not have to state why you want the records before we
  respond to your request. FOIA does, however, allow the Arlington County Sheriff's
  Office to require you to provide your name and legal address.
- FOIA requires that the Arlington County Sheriff's Office make one of the following responses to your request within the five-day time period:
  - We provide you with the records that you have requested in their entirety.
  - We withhold all of the records that you have requested, because all of the records are subject to a specific statutory exemption. If all of the records are being withheld, we must send you a response in writing. That writing must identify the volume and subject matter of the records being withheld and state the specific section of the Code of Virginia that allows us to withhold the records.
  - We provide some of the records that you have requested but withhold other records. We cannot withhold an entire record if only a portion of it is subject to an exemption. In that instance, we may redact the portion of the record that may be withheld and must provide you with the remainder of therecord. We must provide you with a written response stating the specific section of the Code of Virginia that allows portions of the requested records to be withheld.
  - We inform you in writing that the requested records cannot be found or do not exist (we do not have the records you want). However, if we know that another public body has the requested records, we must include contact information for the other public body in our response to you.
- If it is practically impossible for the Arlington County Sheriff's Office to respond to your request within the five-day period, we must state this in writing, explaining the conditions that make the response impossible. This will allow us seven additional working days to respond to your request, giving us a total of 12working days to respond to your request.
- If you make a request for a very large number of records, and we feel that we cannot
  provide the records to you within 12 working days without disrupting our other
  organizational responsibilities, we may petition the court for additional time to respond
  toyour request. However, FOIA requires that we make a reasonable effort to reach an

agreement with you concerning the production or the records before we go to court to ask for more time.

## **Costs**

 A public body may make reasonable charges not to exceed its actual cost incurred in accessing, duplicating, supplying, or searching for the requested records. No public body shall impose any extraneous, intermediary, or surplus fees or expenses to recoup the general costs associated with creating or maintaining records or transacting the general business of the public body. Any duplicating fee charged by a public body shall not exceed the actual cost of duplication. All charges for the supplying of requested records shall be estimated in advance at the request of the citizen as set forth in subsection F of

- o § 2.2-3704 of the Code of Virginia.
- You may have to pay for the records that you request from The Arlington County Sheriff's Office. FOIA allows us to charge for the actual costs of responding to FOIA requests. This would include items like staff time spent searching for the requested records, copying costs, or any other costs directly related to supplying the requested records. It cannot include general overhead costs.
- If we estimate that it will cost more than \$200 to respond to your request, we may require you to pay a deposit, not to exceed the amount of the estimate, before proceeding with your request. The five days that we must respond to your request does not include the time between when we ask for a deposit and when you respond.
- You may request that we estimate in advance the charges for supplying the records that
  you have requested. This will allow you to know about any costs upfront or give you the
  opportunity to modify your request in an attempt to lower the estimated costs.
- If you owe us money from a previous FOIA request that has remained unpaid for more than 30 days, The Arlington County Sheriff's Office may require payment of the past-due bill before it will respond to your new FOIA request.

### **Commonly Used Exemptions**

The Code of Virginia allows any public body to withhold certain records from public disclosure. The Arlington County Sheriff's Office commonly withholds records subject to the following exemptions:

- Personnel records (§ 2.2-3705.1 (1) of the Code of Virginia) or records relating to administrative investigations (§2.2-3705.3).
- Records subject to attorney-client privilege (§ 2.2-3705.1 (2)) or attorney work product(§ 2.2-3705.1 (3))
- Criminal Record exemptions (§2.2-3706)

• All records of persons imprisoned in penal institutions in the Commonwealth provided such records relate to the imprisonment (§2.2-3706-B.4.).

- Vendor proprietary information (§ 2.2-3705.1 (6))
- Records relating to the negotiation and award of a contract, prior to a contract being awarded (§ 2.2-3705.1 (12))
- Records subject to attorney-client privilege (§ 2.2-3705.1 (2)) or attorney or legal work product (§ 2.2-3705.1 (3))
- Vendor proprietary information software (§ 2.2-3705.1 (6)) or agency software (§2.2-3705.1 (7))
- Records relating to the negotiation and award of a contract, prior to a contract being awarded (§ 2.2-3705.1 (12))
- Engineering and architectural drawings, operational, procedural, tactical planning or training manuals, staff meeting minutes or other records, the disclosure of which would jeopardize the security of any governmental facility, building or structure or the safety of persons using such facility, building, or structure (§ 2.2-3705.2 (14))
- Medical and mental health records (§ 2.2-3705.5 (1); (§ 32.1-127.1:03);
- Confidential proprietary records related to a bid on a public construction project (§2.2-3705.6 (10))
- Records relating to a criminal investigation or prosecution (§ 2.2-3706 (B)(1))
- Records submitted in confidence to agents of the Department's Special Investigations Unit (§ 2.2-3706 (B)(2))
- Records of inmates incarcerated in correctional facilities (§ 2.2-3706 (B)(4))
- Law enforcement records containing specific tactical plans, the disclosure of which would jeopardize the safety or security of law enforcement personnel or the general public (§ 2.2-3706(B)(5))
- Criminal history records (§ 19.2-389)
