Crystal City Metro East Entrance

- July 2023 Arlington County approved Comprehensive Agreement for East Entrance, LLC to perform Final Design and Construction
 - Defines the terms and conditions of the Design-Build project delivery
 - Contract award \$117.2M; project budget \$141.6M
- September 2023 County approved Project Coordination Agreement with WMATA. Cost estimate \$9.4M
 - Sets requirements for the Project to be designed and constructed in accordance with WMATA's standards, guidelines, and policies
 - County to reimburse WMATA for costs incurred during design and construction, including staff time, inspectors, escorts, bus bridging, and the purchasing of WMATA-specific equipment, such as fare machines and fare gates
- January 2024 County issued Notice-to-Proceed to Gannett Fleming for Construction Management and Quality Assurance Services. Contract award \$8.2M

Crystal City Metro East Entrance

Final Design: Started in August 2023

- Work separated into four Design Packages
 - DP1 Civil Enabling Work
 - DP2 New Entrance Tie-in to existing station
 - DP3 New Entrance Structure outside of existing station
 - DP4 Site Restoration
- Three design review Iterations:
 - 60% Design: underway, completion Winter 2024
 - 90%: underway, completion Spring 2024
 - 100%: starting Summer 2024 and completion Winter 2025
 - Issued for Construction (IFC) Fall 2024 for Package 1 and Winter 2025 for Packages 2 & 3
- Coordination with Adjacent County-led projects;
 Metro Market Square and 18th Street South
 Realignment

Crystal City Metro East Entrance

Construction

- Early activities to relocate fiber optic ductwork bisecting the site to start in January 2024
- Construction start Fall 2024
- Anticipated to last 2.5 years
- Coordination with WMATA to minimize construction-related impacts to riders and the public
- Notification to riders and the public on construction status and mitigation measures to reduce impacts
- New Station Entrance opens April 2027




New entrance location at 18th Street South & Crystal Drive looking northwest



Project Timeline

- ➤ Design Completion: Aug 2023 Feb 2025
- ➤ Construction Completion: Aug 2024 Mar 2027



Key Outcomes

Design pivot to an at-grade station entrance to reduce project costs and provide greater design flexibility for the East Entrance

JBG Smith provided Arlington County a "Guaranteed Maximum Price" proposal to finalize the design and construction

Comprehensive Agreement for Final Design and Construction as Design-Build with JBG Smith and Clark Construction; NTP August 2023

Initial design activities started in August 2023; Construction activities to start in August 2024 and last 2.5 years Target opening date Fall 2027 in coordination with other adjacent projects

East Falls Church Bus Bay Expansion

Project Scope

- Expand bus loop capacity by adding three new bus bays and shelters and replacing existing shelters
- Replace the signal at the bus loop entrance/exit on N Sycamore Street
- Include pedestrian access improvements from the Metro Parkand-Ride lot, improvements to the accessible parking access
- Project Budget \$12.7M




Existing East Falls Church Bus Loop off N Sycamore St

- Complete Final 100% Design: January 2024
- Engineer of Record sign & seal 100% design drawings: January 2024
- County Board approval of Project Coordination Agreement with WMATA: January 2024
- Issue Invitation to Bid: March 2024
- Issue NTP to Contractor: May 2024




Plan View of Expanded East Falls Church Bus Loop

Current Status

- Final revisions to 100% design documents underway
- Task order issued to AECOM for construction management services

Ballston-MU Metro West Entrance

Design and construct a second entrance to the Ballston –MU Metro Station at Fairfax

Drive and N Vermont Street.

 New entrance enhances connectivity within the Ballston area

- Extends the distance pedestrians can reasonably walk to access the station by nearly one-quarter mile
- Provides additional egress path for evacuation during an emergency
- Relieves congested conditions by providing more even distribution along the platform
- County-led project with coordination with WMATA
- Adopted FY23-32 CIP Project Budget is \$150M




Ballston-MU Metro West Entrance

Status

- STV finalizing the 35% design plans; anticipate completion in winter/spring 2024
 - WMATA and the County provided comments
 - Coordination underway to closeout comments
- Developing procurement documents including scope of work and evaluation criteria for issuance of a Request for Qualifications (RFQ) followed by Request for Proposal (RFP) for Design-Build services






New entrance location at Fairfax Drive and N Vermont Street

- ➤ Issue NTP for Design Build Contractor: Summer 2025

- Complete 35% design documents
- Complete procurement process for Design Build services: Spring 2025
 - Issue RFQ to select short list of firms
 - Issue RFP to the short-listed firm
 - Issue NTP to selected Design Builder
- Advance Design Build phase: Summer 2025 Spring 2029

Shirlington Transit Center Expansion

Project Background and Objectives



Background

- The Shirlington Bus Station has been in operation since 2008.
- Located at S Quincy Street near the intersection of S Randolph St and 31st Street S, this station is South Arlington's regional transit center connecting riders to Alexandria, Fairfax County, Metrorail and VRE stations.


Objectives

- Expand the station's capacity to improve the integration between systems and increase capacity to accommodate future service increase from regional BRT on the West End Transitway in Alexandria
- Comprehensive facility assessment for effective asset management and facility optimization



Shirlington Transit Center Expansion

Redevelop the parking lot adjacent to the Shirlington Bus Station to increase bus bay capacity and upgrade the facility to meet future service demand.

Floating Bus Stops

- Provides dedicated waiting and boarding areas for passengers
- Provides boarding islands to allow creation of accessible in-lane stops
- Separated from sidewalks by bike channels
- Safety metal railing provides a separation barrier between cyclists and pedestrians
- Amenities: Shelter, benches, trash bins.





Current Floating Bus Stop

Floating bus stop installed at Wilson Blvd and N Pierce Street; designs underway for 25 additional floating bus stops





Concerns & Issue

- Way-finding for individuals with low-vision
- Mitigation for the conflict between pedestrians and bicycles

Proposed FY25 DRPT Grant Applications

County seeking funding totaling nearly \$31M through the DRPT MERIT Grant Program for the following projects/programs. Applications due by February 1.

- ART Facilities Electrification: \$13.7M
- ART Fleet Expansion: \$4.5M
- ART Replacement Buses: \$10.6M
- Bus Stop Accessibility Improvements: \$926K
- Bus Stop and Shelter State of Good Repair: \$627K
- Transit Signal Priority: \$347K
