
## Fire Station 10 Coverage Area





#### Temporary Fire Station Background

- On July 16, 2016 meeting, the County Board approved the License Agreement between Arlington County and Arlington Public Schools to locate the temporary fire station on the site of the Wilson School
- At this meeting, the County Board directed the County Manager to convene a 60 day public review process to determine whether the Wilson School location was the most feasible, or if it was better suited for Rhodeside Green Park, a parcel of land along Lee Highway next to the Holiday Inn, or another site that may be identified during this review.





# Wilson School Potential Temporary Fire Station 10 Layouts






Would require off-site parking for school use and temporary outdoor recreational space on-site and/or off-site


#### Potential Wilson School Site Layout




# Rhodeside Green Park Potential Fire Station 10 Layout



Requires clearing the site, potential utility relocations to support use of the site as a temporary fire station, and repurposing site with park amenities upon termination of the temporary fire station use


### Parcel Near Lee Highway Holiday Inn

Not feasible to site entirely on County parcel




Requires removal of on-street parking and significant grading and utility relocations and would not be able to accommodate parking on-site
