- In April 2021 DRPT released their draft FY22 Six Year Improvement Program (SYIP) which recommended two grant awards for the County totaling \$14.7M
 - Replacement Bus Purchase (20 buses)
 - Replacements Transit ITS Assets (equipment and software replacement)
- Total amount proposed for FY22 DRPT Capital Assistance Program is \$98M statewide; awards focused on State of Good Repair (SGR) projects
- DRPT received a significant increase in the number of applications and prioritized FY22 Capital Assistance grant awards for SGR projects
- Commonwealth Transportation Board will approve grant awards in June/July 2021
- County Board slated to approve DRPT grant agreement in September 2021
